

MUNICIPALITY OF NORTH CYPRESS-LANGFORD

BY-LAW NO. 15/2018

A By-law of the Corporation of the Municipality of North Cypress-Langford and the committees thereof, for the purpose of fixing the remuneration of the members of Council pursuant to Section 124 of The Municipal Act.

The Council of the Corporation of the Municipality of North Cypress-Langford, pursuant to Sections 124 of The Municipal Act, duly assembled ENACTS as follows:

1. THAT the Municipality of North Cypress-Langford in lieu of all other indemnities shall pay the members of the Council a monthly indemnity as follows:
 - (a) To the Reeve an indemnity of \$496.05 bi-weekly, and
 - (b) To the Deputy Reeve an indemnity of \$465.30 bi-weekly, and
 - (c) To each member of the Council an indemnity of \$440.30 bi-weekly.
2. THAT the municipality shall further pay to each member of Council:
 - (a) \$15.00 for each hour actually and necessarily spent by him/her in the performance of duties, works or services performed pursuant to resolution of Council.
 - (b) The actual living expenses to go on special journeys beyond the limits of the municipality on the business of said municipality, as well as the amount of \$125.00 per day for each day said member of Council is actually engaged in the business authorized by resolution of Council.
 - (c) 50 cents per kilometre for each kilometre actually and necessarily travelled by him/her in the performance of the duties, works or services to which clause (a) and (b) hereof applies.
 - (d) A daily allowance for each meal up to the maximum listed below, with proof of receipt, at the following rates:


(i) Breakfast	\$15.00
(ii) Lunch	\$20.00
(iii) Dinner	\$25.00

when performing the duties, works or services to which clause (a) and (b) hereof applies.
 - (e) Administration allowance of \$50.00 a month to be submitted by December 31st each year.
 - (f) Out-of-pocket registration or tuition in attending courses authorized by resolution of Council.
3. THAT no member of the Council shall be entitled to any payment, mileage, remuneration, or indemnity, in any year except as is provided for in this By-law or by resolution of Council.
4. THAT annual percentage increases to the monthly indemnity shall occur on January 1 of each year following the passing of this by-law at a rate equal to the annual percentage increase designated as the Cost of Living Allowance.
5. THAT this By-law shall come into force and effect on November 12, 2018.
6. THAT By-law No. 1/2015, and all other "Indemnity By-laws" are hereby repealed.

DONE AND PASSED as a by-law of the Municipality of North Cypress-Langford, at Carberry, in the Province of Manitoba this 10th day of December, 2018.
